Sub.: Clarification regarding temporary closure of operation of MDF plant, Chikmagalur, Karnataka

Dear Sir/Madam,

We have received your above referred email seeking 'clarification regarding the announcement submitted by the Company in relation to Updation on temporary closure of operation of Company's MDF plant, Chikmagalur, Karnataka.

In this regard, our clarification on the same is as mentioned below:

1. Expected quantum of loss/damage caused:

Clarification: The closure of our Chikmagalur MDF Unit for Approximately 45 days was on account of "**Planned preventive maintenance activities to be undertaken thereat as well as to replace some of the major parts of the plant**". Thus, the Company temporary closed the said plant with all the precaution and it is in general practice. Further, it is decided by Company to close the plant for another period of approximately 10 days due to heavy rain thereat.

The necessary equipment and parts which are to be replaced are kept outside the building and due to heavy rain, the Company is unable to complete the pneumatic conveying system works within stipulated time. Whereas the boiler/energy plant related works, it was completed within stipulated time. Further, the Company is trying to complete the Pnematic system works within approximately 10 days as informed.

2. Whether loss/damage covered by insurance or not including amount:

Clarification: As it is a planned preventive maintenance activities as well as to replace some of the parts in the unit, it is not covered in the Insurance as taken by the Company. However, the loss caused to materials, if any due to heavy rain may be covered in the insurance taken by the Company and Company will make claim with the insurance Company.
