Remaining 36 were convertible warrants holders on that date. The company has allotted 66,00,000 Equity Shares of rs. 1 each to 14 Non-Promoter Group category on 24.06.2025 by conversion of warrants. These 66,00,000 equity shares were allotted before the date of 30.06.2025. The listing process, corporate action for crediting shares and trading process has been completed and shares have been listed on the stock exchange during the quarter ended on 30.09.2025. Further, these shares are locked-in. So, we shown it under the locked-in column.
